Recently CMS/Data announced CMS OPEN, a new comprehensive financial management system designed for the legal industry. CMS OPEN delivers the power and function of the company's successful CLO*2 product to those firms who are ready to take advantage of client/server technology in a Windows environment. CMS OPEN ensures complete integration of the various applications required for a productive and profitable law office, while providing such crucial factors as flexibility, platform independence, ease of use, and a solid

foundation for growth. CMS OPEN is the most comprehensive law office management system available from any single vendor.

In 1989, CMS/Data developed PC DOCS (Document Organization & Control System) to meet the need for tracking, storing and retrieving the countless number of documents generated by law firms. Network based, PC DOCS allows users to search for documents by any word, group of words, words in proximity, or phrases. It can also manage databases created by other DOS-based programs, i.e., spreadsheet, graphics packages, etc. Today, PC DOCS is the predominant document management application in the marketplace and has won both *PC Magazine*'s Editor's Choice award and *WordPerfect Magazine*'s Reader's Choice award for two consecutive years. With over 400 dealers worldwide, the product has been installed in more than 400 law firms, industrial organizations, and governmental agencies.

In the first quarter of 1991, CMS/Data acquired two legal software developers, Canterbury Systems of Toronto and CompInfo Inc., located in New York. As a result of this expansion, CMS/Data offers a breadth of products without parallel. CLO*2 and CMS OPEN are the eminent legal financial packages available today and PC DOCS is the market leader in the document management field. CompInfo's Corporate LawPack for Windows software is foremost in the corporate legal environment and finally, the assortment of practice management applications available through Canterbury are tops in the industry.

Canterbury's most recent developments include two applications, *MarketSense* and *DocuDraft*. **MarketSense** is a powerful database application that allows law firms to track both client and prospect information. With built-in document assembly, **MarketSense** becomes an invaluable analysis and reporting tool. **DocuDraft** is a WordPerfect-integrated document-assembly application that allows users to create forms, compose agreements, and even generate reports. It provides power and flexibility while maintaining easy-to-use functionality.
